Cancellation Conditions

- For a cancellation before September 15th 2024 no cancellation fees applicable, 100% refund of registration fees, less 500 € of administrative costs
- For cancellation between September 16th 2024 and January 15th 2025: Refund of 50% of registration fees, less 500 € of administrative costs
- For cancellation after January 16th 2025: no refund
- For cancellation during the program: no refund
