## **Accommodation**

Participants are free to choose their own accommodation. Hotel suggestions can be provided by the EAO, near the university.

## **Cancellation Conditions**

Cancellations must be sent in writing to the EAO Office. Refunds, **if applicable**, will be processed after the event.

## **Cancellations by the participant** for any reason:

- For a cancellation before March 31<sup>st</sup> 2026, no cancellation fees applicable, 100% refund of registration fees, less 150 € of administrative costs
- For cancellation between April 1st and June 30th 2026: Refund of 50% of registration fees
- For cancellation after July 1st 2026: no refund

# Cancellation by the EAO:
